### ACKNOWLEDGEMENT, WAIVER, RELEASE OF LIABILITY & INDEMNITY

#### READ CAREFULLY BEFORE SIGNING.

(You are waiving certain LEGAL RIGHTS, including right to sue).

IN CONSIDERATION of and as part of payment for the right to participate in hunting, I, for myself, my heirs, executors, administrators and estate trustees, do HEREBY RELEASE, WAIVE AND FOREVER DISCHARGE the Nottawasaga Valley Conservation Authority (NVCA) and all their respective agents, officers, elected and appointed officials, servants, contractors, representatives, successors and assigns OF AND FROM ALL claims, demands, damages, costs, expenses, actions and causes of action, where in law or in equity, in respect of death, injury, loss or damage to my person or property whosoever caused, arising or to arise by reason of my participation in hunting on NVCA lands, whether prior to, during or subsequent to hunting AND NOTWITHSTANDING that the same may have been contributed to or occasioned by the negligence, breach of contract, break of statutory duty of care and/or breach of the *Occupiers' Liability Act* of Ontario by any Releasee.

I FURTHER UNDERTAKE TO HOLD AND SAVE HARMLESS and AGREE TO INDEMNIFY all of the aforesaid from and against any and all liability incurred by any or all of them as a result of or in any way connected to my participation in hunting on NVCA lands, including but not limited to all costs and expenses incurred by or associated with any rescue.

I WILL OBEY AND FOLLOW THE INFORMATION, INSTRUCTION AND RULES of NVCA, including, but not limited to the following:

- Participants shall maintain all necessary Provincial and Federal licenses required;
- Participants shall obey all Provincial and Federal laws pertaining to hunting, and use of NVCA lands, including the *Conservation Authorities Act*;
- Participants are not permitted to use wheeled motorized vehicles;
- Participants are responsible for adhering to property boundaries and are not to trespass on private property;
- Construction of deer stands and hunt camps are strictly prohibited, all stands must be clearly labeled;
- Participants will hold insurance through their valid OFAH membership;
- Participants shall conduct themselves to a high standard of ethical and sportsmanlike behaviour;
- Participants shall engage in hunting in a safe manner, and wear adequate 'hunter orange' as required;
- Participants shall display permits in a clear manner.

THE TERMS HEREOF shall serve as a release for my heirs, executors, administrators and estate trustees and for all members of my family, including any minors accompanying me. This is a legal and binding document which I have read, and which I understand and agree to the terms and conditions thereof.

I can read and understand the English language, and am aware that by signing this document I am waiving certain legal rights which I or my heirs, executors, administrators and estate trustees and all members of my family, including any minors accompanying me may have against the Releasees.
